As a board we are proud of the recent refresh of Body Safe and the positive feedback attesting to the continued need for RPE programmes. We wish to thank our Executive Director Debbi for her excellent leadership navigating the team through the changing political landscape and are pleased at the stability RPE has currently in a challenging climate.

Director's Report

Debbi Tohill

I am pleased to present the Annual report for the fiscal year 2023-2024.

Evaluation shows young people and school staff continue to value our programmes and we have had an increase in demand this year. After a significant review of BodySafe, we have been pleased to roll out the refreshed programme in 2024. Whilst many people have contributed to this work, I would like to make special mention of our Programme Development Lead, Lesley-Ann Guild, who has led this work.

Whilst we have seen a more settled year than recent years, challenges remain, and we have had to put extra resource into ensuring the safety and well-being of our staff and the students we work with. Students are reported to be showing high levels of mental health issues such as anxiety and depression. Whilst the new coalition government has discussed removing and refreshing the Relationship and Sexuality Guidelines in the school curriculum, to date there has been no definitive action on this and we continue to work closely with our schools and receive advice from Ministry of Education.

I would like to express thanks to all who contribute to RPE's work from our casual educators, committed staff and Leadership team and our volunteer Board. With a refreshed board I am excited to see RPE's future direction. I know that our work makes a difference to all that we work with, whether it is a Year 10 student learning about consent for the first time to community workers keen to explore how their attitudes and believes can contribute to creating safe cultures for their communities.

We remain committed to eliminating sexual violence in our communities and look for opportunities to work in new areas.

Goal One:

We lead and contribute to the prevention of sexual violence with advocacy and awareness raising

RPE has actively contributed to and/or attended national and local initiatives:

Te Aorerekura, our national strategy for eliminating family violence and sexual violence and it's Action Plan.

Te Puna Aonui's hui on the National Strategy for eliminating Family Violence and Sexual Violence and Action Plan Te Aorerekura.

Meetings with the Minister for Prevention of Family & Sexual Violence, Marama Davidson in 2023.

The Executive Director is the Sexual Violence Prevention representative for Auckland Women's Coalition for Family & Sexual Violence and represents the Coalition on Netsafe's WOSP group.

The Executive Director is the Prevention Portfolio holder on TOAH-NNEST and chairs monthly meetings for the Prevention sector.

The Programme Development Lead is an active member of the Rainbow Violence Prevention Network (RVPN).

RPE is active in sector interagency meetings with a range of providers of sexual health information in Auckland. These include Sexual Wellbeing Aotearoa (formerly Family Planning), Burnett Foundation (formerly NZ Aids Foundation), Village Collective, Te Kaha o Te Rangatahi Trust, Auckland Sexual Health Service, Rainbow Youth, the Light Project and others. Joint training or network meetings are held for our teams during school holidays and are fantastic opportunities for the teams to learn from each other. Managers of these organisations also meet regularly to share sector knowledge and expertise.

The Executive Director is the Chair of Project Restore who provide restorative justice for survivors of sexual violence.

We supported several students doing their Degrees, Master's or PhDs in sexual violence prevention, schools education programmes and related topics.

Goal Two:

We support organisations to embed sexual violence prevention practices with professional training and development

We continue delivery of sexual violence prevention workshops to University of Auckland to staff, resident advisors and student leads as part of their Cultures of Consent action plan.

- A really insightful workshop that made me much more aware of the actions and types of support people can get, as well as how to address any situations

We completed the Best Practice Guidelines for people working with rainbow communities. This work was in partnership with the Rainbow Violence Prevention Network and funded by Te Puna Aonui.

RAINBOW BEST PRACTICE GUIDELINES We partnered with the New Zealand Police to deliver workshops to bar and hotel staff with the Don't Guess the Yes campaign. This workshop ensures bar and hospitality staff have the skills to support patrons who may experience sexual harassment or violence and know how to step in safely if needed. These workshops have been supported by Auckland Council.

- It has given me more awareness of situations and how to approach and defuse difficult scenarios

We hosted a showing of The Lie - the Grace Millane story followed by a panel MCed by Hadley Taylor with Debbi Tohill and Detective Inspector Scott Beard.



We met with the Inspirasi students who are working in their communities in Indonesia on topics of sexual violence and family violence. Inspirasi is a capacity building programme for emerging young civil leaders in Indonesia to grow their knowledge, skills and confidence.

We presented the Rainbow Best Practice guidelines to The Sexuality Information Network (SIN) which is attended by Public Health Nurses, Sexuality Educators, community workers and other organisations.

We contributed to Le Va's community participation workshop.

Professional development trainings on sexual violence prevention and dealing with disclosures have been provided including Heart, Youthline, Ma Te Huruhuru, Auckland Council frontline staff, Future Skills, University of Auckland medical students and New Zealand Police and several community groups and schools including teachers, nurses, counsellors and other school staff.

Goal Three:

We are innovative in developing current and new workstreams to secure opportunities for our sustainability

As the Government's national strategy for Family Violence and Sexual Violence Te Aorerekura beds in, RPE has been eager to take up new opportunities to grow and develop current and new workstreams.

We partnered with Auckland HELP and Curative to respond to an ACC tender to develop resources for child sexual abuse. This project became a learning experience for ACC and its evaluation partners, Litmus, and the other organisations involved. Our final product "The Courage Club" launched in October 2023, a series of podcasts hosted by Emily Writes on parents' experiences with children with disabilities. (Action 36)

We have been pleased to enter a partnership with Shine to deliver workshops to frontline court staff. Our two Lead educators have passed Shine accreditation to deliver these workshops (



We continued to deliver a series of workshops in Auckland for Family Start providers (Action 32). hese entry level workshops focussed on understanding sexual violence, recognising child abuse and how to respond. Workshops were delivered in Hastings, Lower Hutt, Taupo, Tokoroa and Gisborne with teams from over 12 organisations attending.

The RPE Board are an important part of the team, providing governance and oversight of our organisation. This year has seen changes on the Board, and we want to acknowledge the contribution made by our Co-Chairs, Bevan Chuang and Mereana Te Pere and our Board Treasurer Melanie Beres who have resigned.

Thanks to Laverne Robinson for stepping into the Chair role and to Charlotte Trevella for her support as Secretary. We are very pleased to welcome new board members Cathy McKenzie, Chillion Sanerivi, Nalini Dutt, Siobhan Patia.

We achieved Level 3 Social Sector Accreditation

Upskilling our staff is very important and we have had a strong focus on internal trainings to Staff have benefited from regular staff trainings with external providers from Inside Out, Health Promotion Forum, Safe to Talk and Netsafe, as well as several inhouse trainings. With the review of BodySafe there has been significant Professional development for the team to ensure they are prepared and confident to deliver the new content.

External trainings have included Treaty training and a workshop with Safe.

Our Strategic Goals (Te Tiriti o Waitangi) include Kawanatanga/Governance, Tino Rangatira/Maori self-determination and Oritetanga/Equity. We are working towards ensuring that these goals are included in all our work, that we are developing relationships with Maori organisations and iwi and wherever possible, offering our services to support others. Staff training is an important part of our commitment to these goals.

We are grateful for the support of our government funders including the Ministry of Health and Oranga Tamariki for their ongoing support of the BodySafe programme and enabling us to do wider community initiatives. We also acknowledge the huge support that we have received from philanthropic, community and gaming trust to meet the increased demand of our Bodysafe Programme for high decile schools.

We thank our Kaumatua, Papa Fred Hollaway and his wife Whaea Marlene for their support with mihi whakatau for all new staff and board members and blessing our premises in Carr Road.

We are very pleased to report a surplus this year.



Our main Programme Delivery is our Programme for secondary school students. Following insights from the literature review and focus groups including schools and our own staff in the first half of 2023, the BodySafe Tiaki Tinana programme has been reviewed and updated to include a greater focus on meeting the needs of high priority learners, particularly rangatahi Māori, Pasifika students and Rainbow communities. There has been a shift in content to ensure a greater focus on harmful gender norms, greater integration of online harm throughout the programme and strengthening the facilitation style.

We worked with Point Associates to undertake a developmental evaluation of the pilot which included focus groups with three of the pilot classes and interviews by phone or email with classroom teachers. A fourth class was included in the pilot but not in the external evaluation due to funding limitations, a focus group with students from that class was run by RPE staff not involved in delivery of content in that school.

We are excited to roll out the updated BodySafe Tiaki Tinana programme across all mainstream schools in 2024.

Working with young people to promote respectful relationships and prevent sexual violence.

This includes a new integrated workbook for participants and updating the pamphlet for students with help seeking information.

Changes to the programme include:

- · Opening and closing lessons with karakia
- Supporting staff to use more Te Reo Māori and including more Māori kupu in resources and programme materials
- More information on digital environments woven through the programme
- Increased focus on the drivers of sexual violence rigid and harmful gender norms
- Introduction of the Four Ds model for bystander intervention (Distract, Delay, Delegate and Direct) with scenarios highlighting a broader range of harmful scenarios more common for students in Year 10.

As part of our evaluation of the programme last year we also identified the need to strengthen our evaluation processes and have streamlined our student evaluation forms to have fewer questions to align with best practice and support more thoughtful responses to each question. We are producing the evaluation report inhouse and plan to run student focus groups in the second half of 2024, enabling us to capture longer term impacts.

Throughout this period our team have noticed a concerning increase in harmful attitudes and beliefs among some students. While these behaviours have always been present and are still a minority they are being expressed more freely by more students and in some instances have included extreme and violent statements such as "trans people should all be taken out and shot'. The increased focus on addressing rape culture and the drivers of violence in the programme is also creating more opportunities to critically reflect on and challenge these attitudes. While important work, this can create challenges for our facilitators and can challenge the thinking of students who hold these violence supportive beliefs.


